Good evening. As you are aware, these are big, heavy wheels. We can rebuild them to your specs. I am quoting:

(2) Archibald wheels, reusing your hubs

59" diameter

(16) spokes that are 3" wide at the hub

3 3/4" wide x 3 1/4" thick felloes (wood rim)

5/8" thick x 4" wide new steel tire

\$1770 each

(minus \$125 each if we use your steel tires instead of new steel)

Shipping the tires may not be cost effective. It may be better to just use new steel.

The lead time is approximately 3 months from the time we receive your hubs (and tires, if reusing them). A minimum 50% deposit is also required to begin, with the remainder, plus any shipping, due when the wheels are ready to ship.

Let me know if you would like to move forward, and I will create an invoice and email it to you, so you can work from an invoice.
