Call to order:

The meeting was called to order by Nelson at 8:03am.

Adoption of Minutes:

A motion was made by Weaver and seconded by Coughlin to adopt the minutes of May 11, 2021 as presented. The motion passed unanimously.

Discussion of 2021 Market Season Planning:

Discussions with EHHD - New COVID guidelines – operational adjustments:

The guidance document that was provided by the District was discussed. Mask wearing will be encouraged. Social distancing will not be required. Sampling will be allowed to occur.

One or two pop up tents will be available for the vaccine clinic that will be run by the District.

DPH guidelines indicate that with large events mask wearing should be required. The Market does not have the resources to police this requirement. There is discretion allowed with the enforcement according to the District. Social distancing with the vendor spaces should be done as long as the operation is not adversely affected. COVID guidelines can be reflected upon on a week to week basis. The District can provide guidance on this.

Food trucks can be spaced out to provide more area for line formation. There is no guidance on customer mask wearing after the purchase of food, which relates to customers eating on site without a mask. The District would like to avoid the congregating of customers waiting for a sample at the vendor tents.

The Market will not be doing sampling at the onset of the season. There may be opportunities to do this later in the season. The barn is considered to be an 'indoor' environment. Sampling outdoors under a tent is a reasonable idea to consider.
